## Background

In September, 2021, Presidio County received an award for a 2020 HAVA Election Security grant. The grant award is \$40,000. The purpose of this grant is to improve the administration of elections for Federal office, including to enhance election technology and make election security improvements to systems, equipment and processes used in federal elections. The County proposes to use the funds to purchase E-poll books and laptops to be used solely for elections. Requests for reimbursement of costs incurred between prior to 12/31/2022 can be submitted against this grant. Since this is an un-budgeted item, a budget amendment is required.

I have reviewed the grant information and certify the availability of this unanticipated revenue.

The budget should be increased in accordance with the attached budget amendment form.
