September 22, 2025 Austin County Commissioners Court met in the 2<sup>nd</sup> floor Courtroom at the Austin County Courthouse with the following present:

## 1. Presentation of award certificates to "I Voted" sticker contest winners.

Kim Rinn (Elections Official) presented plaques to contest winners. Picture taken with the court.

## 2. Petitions or Requests from the Public.

Bridget Bryan spoke to the court on behalf of citizens against BESS and future generations. Would like the court to look at creating a 391 which is to be used on HB150 to play a larger role on cyber protection. If the county already has a 391 in place, then it is possible that only an amendment would need to take place making an easy fix to it.

Judge Lapham explained that a 391 is basically an agreement between 2 governing bodies and can carry more weight when dealing with a state agency.

Billy Doherty (County Auditor) presented draft audit and stated final audit should be presented at next court.

Donna Jacob thanked the court for their continued support standing up for the Austin County communities against BESS.

3. Consideration and action to adopt FY 2025-2026 General, FM & Lateral, Road & Bridge, and Debt Fund Tax Rates.

Commissioner Reed motions to set tax rate for General (M&O) at 0.31700, F/M & Lateral at 0.07379, R&B Special at 0.07575, Debt Requirement at 0.03723 creating a total of 0.50377.

4. Discussion and action to approve 2025-2026 Compensation Order.

Sheriff Brandes explained that this is part of their incentive to keep them improving in their position and part of their pay package to keep them employed with us. This has been paid in prior years.

Judge Lapham advised rates are remaining same as previous year.

Motion to Approve: Commissioner Reed, 2<sup>nd</sup> Commissioner Rinn, passed (4-0)

6. Consideration and action to approve FY 2025-2026 clothing allowance for S.O. plain clothed personnel.

Sheriff Brandes stated this is for narcotics officers and those not in uniform as part of their pay package.

7. Consideration and action to approve Amendment to Order of November 4, 2025 Special Election.

Kim Rinn (Elections Official) stated Wallis needs to be pulled off notice for early voting. A while back it was thought that City of Wallis would have a contested election and need early voting, however, early voting is no longer needed for City of Wallis due to the race not being contested anymore.

9. Discussion regarding the renewal of Election Systems & Software, LLC agreement, and action as appropriate.

Kim Rinn (Elections Official) stated current ES&S expires October 1, 2025 therefore a renewal is needed. The rate being charged will be the same rate we have had in the past. Renewal will be every 2 years. After 2 years an increase of 10% will occur.

10. Consideration and action to purchase ECM Elections Software Program for voter registration and elections records management.

Kim Rinn (Elections Official) stated currently we have a voter registration and election retention software through Vista and a new Secretary of State Software we are processing voter registration through. The two software are not communicating together well. The inhouse software is not allowing to give retention records. We currently have carbonite on the computer that in the event there is a failure we have a backup. The new ECM Elections Software Program would be cloud based and not require carbonite or a stand-alone computer. Multiple counties currently using the new software program.

Judge Lapham inquired if this new program is needed for the upcoming election in November.

Kim Rinn (Elections Official) advised it would be helpful if in place before upcoming November elections. Having this new program would also free up space in the server.

Commissioner Cerny inquired on the contract time frame.

Kim Rinn (Elections Official) this contract is quoted for 2 years.

Commissioner Reed stated majority have stayed the same. However, Shannon Hannath (Road and Bridge Administrative Assistant) found an exception in Suncoast's Contract.

Judge Lapham inquired if we have seen exceptions like this in other contracts.

Commissioner Reed stated this is not something he has ever seen.

Judge Lapham read exception to the court.

Judge Lapham inquired on where their bid falls.

Commissioner Reed advised they are not the lowest bidder.

Judge Lapham inquired who supplies fuel now.

Shannon Hannath (Road and Bridge Administrative Assistant) stated usually we use the lowest bidder.

Judge Lapham asked who is the lowest bidder.

Commissioner Cerny stated low bidder is Key Performance.

Judge Lapham stated it is up to the commissioners if Suncoast bid should be pulled out.

Commissioner Reed motions to approve all bids except Suncoast because it is nonconforming bid with bid requirements.
