1. PUBLIC HEARING ON 2020-2021 FY BUDGET

Billy Doherty (County Auditor), requested that instead of upgrading financial server move to Cloud. The transition could possibly cost up to \$75,000. Currently pay \$25,000 per month for Financial software. Rate will go up to \$40,000 per month. Currently this is paid from 127 fund.

Pay out of current budget.

Judge Lapham requested Commissioners withdraw their Motion and Second.

There is a change in Department 102 District Judge. Sal/Crt Adm Salary was changed to \$25,599, FICA \$6,708 and Retirement \$8,390 for a total of \$103,248.

Changes to Compensation Order are Entry Level positions were increased to \$13.13 (no experience) and \$13.65 (experience). County Auditor salary does not reflect a 3% percent increase. The County Auditor's salary cannot be more than the County Judge's salary. Cannot increase Auditor salary a full 3%. Human Resource Admin position increased to \$16 per hour. New position for County Clerk at \$15 per hour. New position for Tax Assessor at \$15.50 per hour. Agri-Life secretary increased to \$13.65. Paid from 51109. Sheriff's Office positions do not all reflect 3% salary increases. Deputies line items in District Clerks office increased to \$11.33 and \$7.17(RMF). County Judge's office deleted Admin position for 24 hours a week. Currently has two positions open. An Administrative Assistant at \$14 per hour and Development Coordinator at \$25 per hour. Road and Bridge #3 needs another position.

Judge Lapham will include all changes to the Compensation Order and will present at next Court meeting.
