Will be half on Cloud and half on our server. Still need to run payroll in STW on server. Will do journal entries to Cloud base version so historical data doesn't change. Will do this until Kronos has their software developed for Cloud based software. STW will stop doing updates for their software as of September 2024. Recommendation to stay with STW.
