1. Petitions or Requests from the Public.

Judge Leedy thanked the public for financing project and Commissioners Court for supervising construction.

Christopher Webb spoke with regard about permit needed for work on Hall Road

2. Discussion and action as appropriate regarding building projects and financing.

Commissioner Lamp presented an invoice from FSC Payment Marking to install keypad for back parking lot at Justice Center for \$1,932.00.

Approve invoice as presented.

Per Commissioner Reed, Wendt Street renovations should begin tomorrow.

Per Commissioner Lamp, will not do mark up on Wendt Street parking lot until after October 1st.

Per Commissioner Rinn, shrubs in front of Wendt Street building will transplant to planter boxes. Per Stacey Villarreal (Agrilife), can raise planter boxes so water flows away from building and prevent standing water. Can pour concrete or use gravel with risers. Commissioner Rinn will get estimates for gravel and concrete. Per Stacey Villarreal, 12 planter boxes were donated by Bluebonnet Master Gardeners. The only expense to the County is gravel or concrete.

Per Judge Lapham, Christensen advertised for bids for subcontractors. Bids were due Thursday at 2 p.m.

Commissioner Reed asked if a ramp should be installed at Wendt Street. Judge Lapham suggested painting a stripe.

Per Commissioner Lamp, doing routine maintenance. Mill Creek at Grubbs and Steck Bottom Roads have been closed about a month. Nelius Road is closed too. Working on bridges. Have three more bridges to build. Nelius, Woodley, and Kiemstedt Road bridges all funded through the State.
