A traditional letter was read by Judge Bilski, from herself and Betty Jez, County Auditor with regard to the 2012-2013 Proposed Budget.

 Discussion regarding any necessary 2012-2013 budget changes/corrections, and action as appropriate

Changes made to the General Fund, Expenditures: page 32 – item #5310, increased to \$150,000.00; item #5752, deleted \$29,500.00; page 33 – item #1999, increase to

\$260,000.00; page 14 – item #1114, increase \$1,222.00 and item #1115, increased to \$41,490.00; page 43 – item #3154, increase \$1,046.00.

Road and Bridge – 3% increase effective October 1, 2012, and a 2% increase in December 2012 as other elected officials requested.

The Court agreed on additions and changes as presented by the Auditor and the new convolutions and additions, with discussion regarding a 3% increase to take effect October 1, 2012.
