The roofing company will add a contingency to the bid to cover the cost of those repairs. Judge Spain also reported that he has received several bids for the new Courthouse roof and will add them to the next agenda for consideration.

Judge Spain reported that the Comdata cards with chips have been ordered.

Judge Spain reported that he has the list of attendees to the Pipeline Safety Training Seminar registered.

Judge Spain reported that the Friends of the Robert Lee Care Center are holding their Brown Bag lunch fundraiser on February 6, 2026.

Public Comment was made by Mike Stevens that he met with the Texas Water Board and reported that Coke County was not included in the state plan. They are looking into getting water from Miles, Texas.

Judge Spain reported that he has signed the voucher for grants for the Early Warning Sirens.
