**PUBLIC HEARING FOR COMMENTS REGARDING THE 2025-2026 PROPOSED BUDGET FOR COKE COUNTY**

The public hearing opened at 9:00 a.m. County Auditor Mike Knittel presented the proposed budget for FY 2025/2026, highlighting their office's issues with the software company in regard to payments. Judge Spain complimented all department heads on their dedication to their budget preparations. Commissioner Waggoner noted that she was missing her extra labor lines in pcts. 1 and 3, and requested that be corrected adding \$5,000 to those lines. There were no comments from the public. Judge Spain announced the presence of a quorum.

**CONSIDER AND TAKE APPROPRIATE ACTION ON ANY CHANGES TO THE  
2025-2026 FISCAL YEAR BUDGET**

Commissioner Chisholm moved to approve the changes to the 2025-2026 budget to the extra labor lines in road and bridge. The motion was seconded by Commissioner Waggoner. Motion carried.

**CONSIDER AND TAKE APPROPRIATE ACTION ON THE ORDER TO ADOPT  
THE OVERALL PROPERTY TAX RATE OF 0.407150/\$100 VALUATION,  
WHICH IS AN INCREASE OF 4.34% FOR THE 2025-2026 BUDGET**

Commissioner Chisholm moved to approve the overall property tax rate be increased by the adoption of a tax rate of 0.407150/\$100 valuation, which is effectively a 4.34% increase in the tax rate for the fiscal year 2025-2026 budget. The motion was seconded by Commissioner Robertson. Motion carried. A roll call vote was taken with all members of the court in favor.

GENERAL TAX RATE OF 0.313350/\$100 VALUATION FOR THE 2025-2026  
BUDGET**

Commissioner Waggoner moved to adopt the General tax rate of 0.313350/\$100 valuation for the fiscal year 2025-2026 budget. The motion was seconded by Commissioner Chisholm. Motion carried. A roll call vote was taken with all members of the court in favor.

**CONSIDER AND TAKE APPROPRIATE ACTION ON ADOPTING THE ROAD

Commissioner Robertson moved to adopt the Road and Bridge tax rate of 0.093800/\$100 valuation for the fiscal year 2025-2026 budget. The motion was seconded by Commissioner Waggoner. Motion carried. A roll call vote was taken with all members of the court in favor.

**REPORTS**




