# COMMISSIONER'S COURT MINUTES FOR MARCH 11, 2024

 Proof of posting of notice in accordance with the provisions of Title 5, Chapter 551, Government Code (Vernon's Texas Codes Ann. 1994) as amended, known as the Texas Open Meetings Act.

Judge Elliott asked for proof of posting and the same was affirmed by Elizabeth Perez, County Clerk, on the north and south door and the bulletin board.

#### 2. Public comments.

#### Elected official reports.

Judge Elliott stated that the county signed papers for the building in Chilton. Judge Elliott also stated that he has Guardian Security scheduled to see the cost to install a security system.

Commissioner Wuebker stated that Judge Elliott and herself are going to meet tomorrow at 3 p.m., with Texas Parks and Wildlife regarding the park grant.

#### Discussion and/or action concerning American Rescue Plan.
