COMMISSIONER'S COURT MINUTES FOR OCTOBER 28, 2024

Judge Elliott asked for proof of posting and the same was affirmed by Elizabeth Perez, County Clerk, on the north and south door and the bulletin board. Commissioner Albright was not present for the meeting.

2. Public comments.

3. Elected official reports.

Commissioner Willberg wanted to give a reminder about the workshop on November 6th in Stephenville.

Discussion and/or action concerning American Rescue Plan.

5. Discussion and/or action concerning Memorandum of Understanding re-obligating American Rescue funds.

Commissioner Green made a motion to approve the Memorandum of Understanding re-obligating to Road and Bridge projects. Commissioner Willberg seconded; motion carried.

Discussion and/or action concerning changes to the Falls County Employee Handbook, re inclusion LGC 154,025.

Commissioner Wuebker made a motion to approve the changes to the Employee Handbook to include the reinclusion LGC 154.025. Commissioner Willberg seconded; motion carried.
