ITEM 19. Discuss and consider updated quotes for a new generator for the Lake Tower. See attached. Judge explained first and foremost the Lake Tower is what runs the county's communication system. The current standby generator is not good and needs to be replaced. Some time back the court approved ordering one from Generator Supercenter, Tomball, Texas, but as of this date they have not given a date when one will be available; also, they want a 50% down payment. A quote was received by Generators-4-U, College Station, Texas, but their estimated time of delivery was 22-24 weeks. McCaffety Electric Co., Inc., Huntsville, Texas has the generator on hand and request 50% payment at time of order. McCaffety's quote is higher than the other two quotes but realize this generator is critical for the communication system should we have a storm and power is loss, Judge said.

Commissioner Cannon moved to approve purchase of generator from McCaffety Electric Co., Inc., and use of funds from the Cares Act for payment; Commissioner Pohorelsky gave a second; Judge Leago said we have a motion and second to approve purchase of generator from McCaffety Electric Co., Inc. and use of funds from the Cares Act for payment for a new generator for the Lake Tower.

Bobbie Duke, Elections Administrator said this \$203,113.00 quote is from Hart Intercivic to retrofit our voting system in accordance with new Election Laws requiring paper ballots. Secretary of State is requiring this quote be approved by the Commissioners' Court so our county can be getting inline for an update. In November the Secretary of State will decide how much of this quote will be reimbursed to the county. When this was first proposed the State said all the cost would be paid but that has changed, Duke said. Judge discussed with the court possible options for payment of this quote until reimbursement is received from SOS.
