ITEM 11. Safety Meeting Monthly Report - Lynn Jeffries

Jefferies reported on six recent septic applications, a fee of \$1,385 was collected. A total of 50 septic inspections were completed in 2019, 50 home structures and 20 mobile homes.

Comment:

Judge Leago reported on a letter received from the Texas Commission on Jail Standards who had recently conducted a re-inspection of Madison County Jail. The letter states "all deficiencies have been corrected and your jail facility is now in compliance with minimum jail standards." The letter and a certificate of compliance is recorded in these minutes for review.

ITEM 18. Discuss and consider proposals for Jail Medical Health Services.

Judge Leago said there are going to be several changes in the way jails do business, costly changes because of the Sandra Bland Act. He called on Larry Shiver, Jail Administrator, Madison County Sheriff's Office to present this information. Shiver said it basically all comes down to the Sandra Bland Act, Senate Bill 1849, and as usual it's an unfunded state mandate with rules to follow. We contacted Toni Joyner, County Auditor, and Paul Miles, Attorney at Law with Texas Association of Counties for legal advice. We were required to contact some 25 companies for Jail Mental Health Services and only two companies responded. We needed three proposals, but we only received two. Most companies were not interested in an average head count of 35 inmates, they wanted to service larger entities. According to Joyner and Miles the county may follow the Government Code 2254 professional consulting services, but commissioners would have to agree and vote to follow Government Code 2254 to accept these two proposals instead of three.

Commissioner Cannon moved to accept Government Code 2254 and consider two proposals for jail medical health services; Commissioner Wiseman gave a second; and Judge called for a vote.

Shiver said with that being approved the two proposals to consider are Southern Health Partners and Turn Key Health. Southern Health Partners services 34 Texas counties including Grimes, Leon, and San Jacinto. They will provide medical and mental health services on-site and remote care for \$62,120 a year, they meet all requirements of law. A description of their services offered are recorded in these minutes. Turn Key Health provides services for one jail in Texas and proposed a bid of \$68,988 annually. See attached. They do not provide the services that Southern Health Partners (SHP) provides. Shiver described all services offered by SHP including TeleCorrect medical for Physician services and TeleCorrect health provides for a Qualified Mental Healthcare Professional. Dr. Helen Morrow is medical physician currently for Madison County Jail and her contract expires soon, so if possible, it would be good to accept one of the proposals to begin when her contract ends, Shiver said. Commissioner Driskell moved to accept Southern Health Partners for Jail Medical Health Services; Commissioner Cannon gave a second; and Judge called for a vote.

ITEM 22. Discuss and consider approving final minor plat recorded in Volume 1657, Page 119, Number 106398 of the Madison County Records. Located in the Zoraster Robinson Survey Tract 26, Abstract 0028, 54.097 acres more or less being divided into three lots with a 20' easement to (1) a subdivided lot of 1.110 acres and to (2) the residual of an 11.00 acre tract, leaving (3) the residual of the original 54.097 acre tract.

Shelly Butts, 911 Coordinator, said the county's subdivision regulations are very generous to developers and she sometimes visits many hours talking to individuals who are planning to divide their land. We do this to protect our citizens and to avoid land lock or other problems that can arise by divisions that don't follow county rules. Many residents are already subjected to less than desirable private roads and they have been paying county taxes for numerous years. The rules that commissioners' court approved were intended to help solve future issues of private roads in multi-lot divisions by avoiding them if possible. Our regulations allow several exceptions such as a family grant, VA tract, lot line adjustments, tracts over ten acres each, however adequate access is an important issue even the state recommends that these exceptions only be allowed if adequate road frontage to a public accessible road. In our county we have a provision for most family grants and we always stress the importance of road frontage for accessibility and direct access. Our regulations read quote, "with the exception of flag lots, the minimum road frontage for all lots shall be 80 feet which shall also be the narrowest width of any portion of the lot, unless a variance has been granted by Commissioners' Court", unquote. Our rules go on to require right of ways roads, streets construction standards and draining provisions. It is my responsibility to handle these land divisions for the county according to rules and regulations I have done this for many years with your support and cooperation. The land division you are asked to consider today does not follow the requirements of the county's regulations. This is a 54.097 acres

tract near the corner of FM 1372 and Bethel Cemetery Road. The developer is requesting to divide a portion of this land that does not have any road frontage. There is an abandoned oil field road on the property and developer plans to extend this road to allow access to the division. As I have received conflicting plans from him, and he is not certain how many lots he plans to construct on the land. I have nothing in writing guaranteeing the construction standards, maintenance or upkeep of the road nor confirmation of weather any more lots are planned with or without road frontage or use of the proposed road. The application is not within the current rules and regulations however commissioners' court can approve a variance to the rules but not by my recommendation at this time. The developer is here if you have any questions for him and the application is included in your packet with surveys and field notes. See attached. The dotted line on survey map represents the oil field road going from FM 1372 to 11-acre tract is 1756 feet, said Gordon Wells, developer and it supplies only the 11 acres. This is 1756 feet of private roadway, he said. We currently do not have anything in our subdivision order that prohibits future divisions, in other words other counties say if you have a parcel of land and someone divides that parcel of land and pulls that 11 acres out then they must wait a period of six months to a year before they can divide another parcel of land from that tract. Our rules do not say that so there is nothing that would prohibit another provision from coming out of the original acreage. The county has the option to bring the road up to standards, 80 feet, and accept it as a county road or you can reject it, she said. Mr. Wells is making future development plans for this land. Commissioner Pohorelsky asked Wells so there are going to be three lots in the remaining 54.097 acres. Wells answered yes. Commissioner Cannon asked who would maintain the road, Wells said it is a private road and landowner who purchases 11-acre tract will maintain it. Butts said, yes but it will be shared in the future. Wells said 100 feet from the front to the next division. Commissioner Cannon asked Butts so what does he need to do to make this comply with the county. He needs to do a full subdivision plat application or you can do a variance, Butts said, you can accept what he has now. The next time he divides he will come back to court and ask for another variance. The 1.110 acres that is out of the 11 acres is owned by the same person they divided the 1.110 acres for their house, Wells said. Judge Leago asked if the owner is aware, they will always be responsible for maintaining the road. Wells replied, yes. Commissioner Cannon asked is the oil company is still using the road, Wells said no. They have not used that gas well in eight or nine years and had contacted the Railroad Commission to see if they plan to abandon it and remove the equipment, but they did not answer. Commissioner Driskell commented on private roads in the county that are not maintained and the hardship it causes property owners. Commissioner Wiseman asked does the property owner of 11-acre tract understand he is going to maintain the road all the way to the highway. Wells said, yes, it's in his contract. Commissioner Driskell said he would like to see the contract and moved to table this agenda item number 22 until the contract could be reviewed. Commissioner Wiseman gave a second to the motion; and Judge called for a vote to table this agenda item 22 until the contract is reviewed by commissioners.

After further discussion and consideration Commissioner Cannon made a motion to accept quote from Generator Supercenter of Houston; Commissioner Wiseman seconded the motion; and Judge Leago called for a vote.
