

MADISON COUNTY SOLID WASTE DISPOSAL RULES –2026

**Madison County Commissioners Court has approved the following
Set of Rules for Solid Waste Disposal in Madison County.**

1. All persons using the Solid Waste Transfer Stations must purchase a permit from the Tax Assessor/Collector's office located in the Courthouse. There are no exceptions. 2026 Permits are required beginning January 1, 2026.
2. Only one Solid Waste Disposal sticker per household is provided for the fee of \$100.00 per year. Proof of purchase will be required to use county disposal facilities.
3. Only residents or property owners of Madison County will be permitted to purchase a permit and use the transfer facility.
4. Bagged household garbage tied at the top will be accepted at the transfer stations. Feed sacks, flour sacks and garbage bags will be accepted, if tied at the top. Cardboard boxes will be accepted only if flattened and tied flat.
5. **No construction materials will be accepted. (including but not limited to sheetrock, shingles, lumber, carpet, etc.)**
6. Used oil will be accepted at Precinct 1 and 2 transfer stations in the designated containers with current permit.
7. Appliances not containing Freon, including refrigerators, freezers, and window air conditioning units, will be accepted at Precincts 2, 3, and 4 with current permit.
8. Appliances not containing Freon, including dishwashers, washers, and dryers, will be accepted with current permit.
9. Other metal items, including scrap metal, will be accepted free of charge with a current Solid Waste Disposal permit.
10. Precincts 2 and 3 will accept other furniture items, including mattresses, box springs, wood products and tree limbs with a current permit (no lumber).
11. Precinct 4 will accept other furniture items including mattresses, box springs free of charge with a current permit (No lumber, No brush).
12. Plastics such as outside containers, computers, monitors, microwaves, televisions or comparable appliances will not be accepted at any transfer station location.
13. **Privately owned trash collecting services or any private businesses WILL NOT be permitted to use the transfer stations for disposal.**
14. Transfer stickers will be prorated starting in August \$75, September \$65, October \$55, November \$45 and December \$35.
15. **Non-compliance with the Madison County Solid Waste procedures could result in prosecution under the Texas Litter Laws.**
