ADDENDUM II RX BID

NOTICE TO BIDDERS

1. Bids are to be submitted on this form. Each bid shall be placed in an envelope, sealed and properly identified with the bid title and delivered or mailed to the County Auditor's Office before the hour and date specified. Late bids will not be considered under any circumstances.
2. Bid unit price on quantity specified, extend and show total. In case of errors in extension, unit prices shall govern.
3. Price must be F.O.B. destination, inside delivery. Show the exact or estimated cost or delivery if transportation is not included in the item cost.
4. Unless otherwise noted, bid prices must be firm for acceptance 60 days from opening dated of the bid.
5. The County is exempt for Federal Excise Tax, State Tax and Local Tax. Do not include tax in bid. If it is determined that tax was included in the bid, it will not be included in the tabulation or any awards and will be deleted from subsequent invoices.
6. Bids cannot be altered or amended after opening time. Any alterations made before opening time must be signed by the bidder or his agent. No bid can be withdrawn after the opening time without approval of the Commissioners' Court based on a reasonable acceptable reason.
7. The County will evaluate the bids and make awards for supplies, materials, services and equipment based on the lowest and best bid which meets the specifications.
8. The County reserves the right to accept or reject all or any part of any bid and award the bid to best serve the interest of the County.
9. Any catalog, brand name or manufacturer's reference used in the bid is descriptive—not restrictive—it is intended to indicate type and quality desired. Bids on brands of like nature and quality will be considered. If Bidding on other than referenced specifications, bid must show manufacturer, brand, model, etc. of article offered. If other than brand specified is offered, complete descriptive information of each article being bid must be included with bid. Articles delivered that are determined by the County not to be or equal or comparable quality of the requested articles shall be picked up by the vendor at no expense to the County.
10. All items bid must be new, in first class condition, including containers suitable for shipment and storage, unless otherwise indicated not the bid. Receipt must be 24 hours or less.
11. Delivery: Bid must show the number of days required to deliver the articles to the specified location under normal conditions after receipt of an order. The right is reserved to reject incorrect or damaged shipments.
12. By signing and executing this bid, the bidder certifies and represents to the County that bidder has not offered, conferred or agreed to confer any pecuniary benefit or other thing of value for the receipt of special treatment, advantage, information, recipient's decision, opinion, recommendation, vote or any other exercise of discretion concerning this bid.
13. Bidder further certifies and represents that Bidder has not violated any state, federal, local law, regulation or ordinance related to bribery, improper influence, collusion, discrimination or other similar crimes and all items or services provided or delivered under any award shall conform hereto.
