BE IT REMEMBERED that on the 13th day of January, A.D. 2020 the Commissioner Court of Howard County met in Special session will all Elected Officials and Department Heads at 1:00 PM followed by a Workshop @ 1:30 PM and Regular session @ 3:30 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, CRAIG BAILEY, Commissioner Precinct No. 2, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4.

The meeting was called to order @ 1:00 PM for a Special session with all Elected Officials and Department Heads. Commissioner Long spoke concerning the needs and travel expenses for the next fiscal year and the budgeting issues the County will be facing, stating that budgeting will need to start now. Jackie Olson, County Auditor, will be getting worksheets out to the department heads to be used for requests. Kathryn Wiseman, County Judge, also informed all departments that anyone with access to County computers must be certified in Cyber Security training and there will be free classes online through Texas Association of Counties (TAC).

The meeting was adjourned @ 1:25 PM.

The Court reconvened into Workshop session @ 1:30 PM.

The Court heard from Rob Pridemore of USI Insurance concerning the need for additional Cybersecurity Insurance Coverage due to all of the Cyber attacks being made against Governmental Agencies and the astronomical costs of recovery. No action was taken at this time.

Sharon Adams, County Treasurer, discussed the Edward Jones 457b Deferred Compensation Plan and the need to appoint a representative for the County. Action will be taken in the Regular session.

Jackie Olson, County Auditor, reviewed Financial Reports for the first quarter of the Fiscal Year and handed out reports to the Court.

Commissioner Cline reported that he had been notified that the Sitel and Goldstar seismographic work and donation has been cancelled. He also stated that the Interstate Steel rental values need to be corrected, suggesting charging \$5000 on the current building and \$2500 for the other building they are wanting to rent for a total of \$7500 monthly. He also suggests giving them 60 - 90 days notice of the increase. This issue will be put on the next agenda for action.

Jimmy Lefler, a citizen, discussed a water contamination issue with the Court stated that he believes oil from old transformers buried by TU Electric are the cause of so many people in this area having cancer. No action needed at this time.

Kathryn Wiseman, County Judge, discussed Howard County Tax Abatement Guidelines and Criteria need to be updated. In addition, Judge Wiseman stated that the Subdivision Rules and Regulations must also be updated. Both of these items will be put on the next agenda for action.

Court recessed until 3:30 PM.

Court reconvened into Regular session @ 3:30 PM.

Kathryn Wiseman, County Judge, presented her certificate for CJIS Security & Awareness training. No action needed.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve Order Prohibiting Outdoor Burning for 90 days as presented by Kathryn Wiseman, County Judge, as requested by Mitchell Hooper, VFD Chief. Commissioner Bailey stated that it also needs to include anything with tails and fins. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Cherrie Burcham, 911 Coordinator, and Zach Johnson of the 911 Board discussed purchasing the NE corner of the property where the Law Enforcement Center is located for a new 911 office. The Court requested a plat of what they are planning for further consideration and the Court will consider just donating the property to them. They will present those plans to the Court at a later date.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Travel Requests as presented by individual offices. They are as follows: R. Williams and Blake Jones from the Sheriff's Office for Weight Enforcement Recertification in Austin; Jury Padron from District Clerk's Office and Trent Powell from the County Clerk to the 2020 CJIS Conference in Denton; and Thad Thomas, District Attorney Investigator, to Texas District and County Attorneys Association Investigator School. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve the Purchase Requests as presented by Jackie Olson, County Auditor. The requests are as follows: Sheriff to send 2 employees to the Academy @ \$1000; Jail for update of camera system @ \$4000; Jail for annual maintenance on Mentalix @ \$3465; and the Auditor to refill postage machine @ \$25000. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Cline to approve door replacement @ the Library for the low bid from A & B Glass @ \$4007.74 as

presented by Jackie Olson, County Auditor, at the request of Baldomar Cortez, Maintenance. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to table action for carpet replacement in the County Clerk's Office as presented by Jackie Olson, County Auditor, at the request of Baldomar Cortez, Maintenance. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Invoices as presented by Jackie Olson, County Auditor, with the late addition of Sales Tax in the amount of \$691.43. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Jackie Olson, County Auditor, did not have any Financial Reports to present at this time due to the fact they were presented during the Workshop.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve the Personnel Considerations as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Long to approve the Treasurer's Monthly Payroll Report for December 2019 as presented Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to approve the Employee Deferred Compensation Plan 457b through Edward Jones as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve all RFB bids to lowest bidders as presented by Brian Klinksiek, County Road

Administrator. They are as follows: RFQ 2020002M (Base) to Tubb Quarry @ \$152,098.02; RFB 2020001 (Sealcoat) to Ronald R. Wagner & Co., LP @ \$700,060.49; and RFB 2020002 (Inverted Prime) to Fuquay, Inc. @ \$146,815.20. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, asked Commissioners to refer anyone who might call them about bids to Brian. He stated it can be a huge problem if different information is given on projects. If he handles all of those issues himself, he can be sure everyone receives the same information.

Brian Klinksiek, County Road Administrator, gave Commissioners a list of projects he has planned for their respective precincts. This was for Commissioner information and no action was needed.

A motion was made by Commissioner Long and seconded by Commissioner Cline to approve the County Clerk Monthly Report for December 2019 as presented by Brent Zitterkopf, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
