Valle of the Howard Indigent Healthcare/Welfare Program. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve the Physician Agreements for the 2020-2021 fiscal year with Steve Ahmed, MD; Rudy Haddad, MD; Robert W. Garcia, MD/Les White, RN FNP; Permian Premier Health Services and

South Plains Rural Health as presented by JoAnn H. Valle of the Howard County Indigent/Welfare Program. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to approve the Personnel Considerations as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Garcia to not pursue the Payroll Tax Deferral Memorandum as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to approve the Treasurer's Monthly Report for July 2020 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey to approve the Treasurer's Monthly Payroll Report for August 2020 as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Court moved back into regular session @ 4:29 PM.

A motion was made by Commissioner Bailey and seconded by Commissioner Garcia to allow 15:15 from the sick pool to an unnamed employee as presented by Sharon Adams, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Bailey to approve a Surface Site Use Agreement between Howard County and Lazy J LTD for a 2nd Radio Tower location as presented by Commissioner Bailey. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve a Surface and Subsurface Use and Easement Agreement between Howard County and

Laredo Petroleum, Inc. as presented by Commissioner John Cline. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Invoices as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to approve the Purchase Requests as presented by Jackie Olson, County Treasurer. A motion was made by Commissioner Long and seconded by Commissioner Garcia to accept the County Auditor's Monthly Report for July 2020 as presented by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

In addition, Jackie Olson, County Auditor, presented a recap of Various Funds – no action needed.

A motion was made by Commissioner Cline and seconded by Commissioner Bailey giving permission to go out on Fuel Bids as requested by Jackie Olson, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Bailey to table the Scanner Proposal for the Howard County Tax Office as presented by Jackie Olson, County Auditor, in the absence of Tiffany Sayles, Tax Assessor-Collector. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Cline to approve the Notice of Fees charged by the Sheriff and Constables of Howard County, Texas effective January 1, 2021 and ending December 31, 2021 as presented by Stan Parker, County

Sheriff. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Bailey and seconded by Commissioner Long to Order Prohibiting Outdoor Burning for an additional as presented by Commissioner Craig Olson in the absence of Mitchell Hooper, VFD Chief. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Road Administrator, presented an executed copy of the County Transportation Infrastructure Fund Grant Agreement (CTIF). No action needed as this was approved in a previous meeting.
