Court Reconvened in Regular Session at 10:15 AM

Yesel Gonzalez, Project Manager with Butler-Cohen gave updates regarding an Asbestos Inspection and a walkthrough of the Howard County Dispatch Expansion Construction Project. The Court discussed the Max Price for the Project with Mr. Gonzalez and No Action was taken.
