**DRIVING SAFETY COURSE REQUIREMENTS**

YOU **MAY** BE ABLE TO REQUIRE THIS CHARGE BE DISMISSED BY TAKING A DRIVING SAFETY COURSE **IF**:

- SUBMIT** A COPY OF THE FRONT OF YOUR VALID **TEXAS** DRIVER LICENSE, **CDL holders ineligible**,
- SUBMIT** A COPY OF YOUR LIABILITY INSURANCE,
- SUBMIT** A COPY OF YOUR **TEXAS** DRIVING RECORD. **3A VERSION** FROM TxDPS . (print from online or mail),
- HAVE **NOT** TAKEN THE DRIVING SAFETY COURSE WITHIN THE PAST TWELVE (12) MONTHS,
- YOUR ALLEGED SPEED DOES **NOT** EXCEED 25 MPH OVER THE LIMIT, OR 95 MPH,
- REMIT \$ **146<sup>00</sup>** COURT COST AS DESCRIBED ABOVE.

**HOWEVER, YOU MAY LOSE THAT RIGHT IF YOU DO NOT PROVIDE WRITTEN NOTICE TO THE COURT ON OR BEFORE YOUR APPEARANCE DATE OF DESIRE TO DO SO. IF YOU TAKE THE COURSE WITHOUT PRIOR APPROVAL FROM THE COURT, THE COURSE MAY BE DISALLOWED.**
