NOTICE OF MEETING TO VOTE ON TAX RATE

A tax rate of \$ 0.6815 per \$100 valuation has been proposed by the governing body of McCulloch County

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for McCulloch County from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval tax rate is the highest tax rate that McCulloch County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that McCulloch County is not proposing to increase property taxes for the 2024 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON SEPTEMBER 23, 2024 AT 11:30 AM at Commissioners Courtroom First Floor of the McCulloch County Courthouse Brady TX 76825.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, McCulloch County is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Commissioners Court of McCulloch County at their offices or by attending the public meeting mentioned above.

No-New-Revenue Maintenance and Operations Rate Adjustments

State Criminal Justice Mandate (counties)

The McCulloch County County Auditor certifies that McCulloch County County has spent \$ 58,405.46 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Sheriff has provided information on these costs, minus the state revenues received for the reimbursement of such costs.

This increased the no-new-revenue maintenance and operations rate by 0.00 /\$100.

Indigent Health Care Compensation Expenditures (counties)

The McCulloch County spent \$ 0.00 from July 1 2023 to June 30 2024 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$ 0

This increased the no-new-revenue maintenance and operations rate by 0 /\$100.

Indigent Defense Compensation Expenditures (counties)

The McCulloch County spent \$ 151,852.50 from July 1 2023 to June 30 2024 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure, and to fund the operations of a public defender's office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For current tax year, the amount of increase above last year's enhanced indigent defense compensation expenditures is \$ 32,109.66

This increased the no-new-revenue maintenance and operations rate by 0.000633 /\$100.

Eligible County Hospital Expenditures (cities and counties)

The McCulloch County spent \$ 0 from July 1 2023 to June 30 2024 on expenditures to maintain and operate an eligible county hospital. For current tax year, the amount of increase above last year's eligible county hospital expenditures is \$ 0

This increased the no-new-revenue maintenance and operations rate by 0 /\$100.
