

McCulloch County Adopted Budget For 2015-2016

This budget will raise more total property taxes than last year's budget by \$80,037.50 which is a 3.13% increase from last year's budget, and of that amount \$32,171.52 is tax revenue to be raised from new property added to the tax roll this year.

The property tax rate for 2014-2015 was \$.483129

The property tax rate for 2015-2016 is \$.4862

The effective tax rate for 2015-2016 is \$.459652

The effective tax rate for maintenance and operations for 2015-2016 is \$.4613

The roll back rate for 2015-2016 is \$.486417

The debt rate for 2015-2016 is \$.022

The total amount of County debt obligations is \$920,000.00
