RESOLUTION 2022-01

A RESOLUTION OF THE CITY OF EASTLAND, TEXAS, ORDERING AN ELECTION TO BE HELD ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING TWO CITY COMMISSIONERS BY THE QUALIFIED VOTERS OF THE CITY OF EASTLAND; AUTHORIZING A JOINT ELECTION WITH EASTLAND INDEPENDENT SCHOOL DISTRICT (EISD), EASTLAND MEMORIAL HOSPITAL DISTRICT (EMHD), AND EASTLAND COUNTY WATER SUPPLY DISTRICT (ECWSD); DESIGNATING POLLING PLACES; AND DIRECTING NOTIFICATION OF SUCH ELECTION

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF EASTLAND:

Section 1. That a general election is hereby ordered to be held on the 7th day of May, 2022, for the purpose of electing Two (2) City Commissioners by the qualified voters of the City of Eastland.

Section 2. That the City of Eastland agrees to hold a joint election with the EISD, EMHD, ECWSD.

Section 3. That the Election Day polls for said election shall be open from 7:00 a.m. until 7:00 p.m. at the designated polling place and the County Joint Elections Administrator is hereby directed to conduct the election.

Section 4. Early voting by personal appearance for the general election shall commence on Monday, April 25, 2022 and continue through Tuesday, May 3, 2022. The Eastland County Courthouse will be open for voting during the early voting period from 8:00 a.m. until 5:00 p.m. Monday thru Friday, except as outlined in Section 5. The place for early voting for such election is hereby designated as follows:

Section 5. As required under Section 85.005 (d), of the Texas Election Code, early voting by personal appearance at the early voting polling place shall be conducted for at least 12 hours on two weekdays, if the early voting period consists of six or more weekdays; therefore, the first and second Tuesday of the early voting period have been designated as the two 12 hours days. The early voting polling place will be open from 7:00 a.m. until 7:00 p.m. on those days.

Section 6. The Board of City Commissioners is authorized to sign an Order of Election and the Chairman to sign the Notice of Election prescribed by the State of Texas. The Notice of Election shall be published in accordance with the provisions of the Texas Election Code and the City Charter.

RESOLUTION NO. 2022-02

A RESOLUTION DECLARING UNOPPOSED CANDIDATES IN THE MAY 7, 2022 GENERAL CITY ELECTION ELECTED TO OFFICE; CANCELING THE ELECTION; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Resolution No. 2022-01 passed on January 18, 2022 called the regular election of Commission members for the City of Eastland, Texas; and,

WHEREAS, at the deadline to file application for a place on the ballot and the deadline to file as a declared write-in candidate, only two candidates had filed to run for two such positions:

WHEREAS, as prescribed in Section 2.052(a) of the Texas Election Code, the City Secretary has certified that:

- 1) Each candidate whose name is to appear on the ballot is unopposed;

Election and hereby declares the unopposed candidates elected to the office, and each shall be issued a certificate of election following the time the election would have been canvassed; and,

FURTHER, the City Secretary is directed to cause a copy of the Order of Cancellation, attached hereto, to be posted on election day at the polling place that would have been used in the election; and,
