## RESOLUTION 2022-02

A RESOLUTION OF THE EASTLAND COUNTY WATER SUPPLY DISTRICT, ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 1, 2021 FOR THE PURPOSE OF ELECTING TWO DIRECTORS BY THE QUALIFIED VOTERS OF THE CITY OF EASTLAND; AUTHORIZING A JOINT ELECTION WITH THE EASTLAND INDEPENDENT SCHOOL DISTRICT (EISD), THE EASTLAND MEMORIAL HOSPITAL DISTRICT (EMHD), AND THE CITY OF EASTLAND; DESIGNATING THE POLLING PLACES; AND DIRECTING THE NOTIFICATION OF SUCH ELECTION

BE IT RESOLVED BY THE EASTLAND COUNTY WATER SUPPLY DISTRICT:

**Section 1.** That a general election is hereby ordered to be held on the 7th day of May 2022, for the purpose of electing two (2) directors by the qualified voters of the City of Eastland.

**Section 2.** That the Eastland County Water Supply District agrees to hold a joint election with the EISD, EMHD and the City of Eastland to be conducted by the County Joint Elections Administrator.

**Section 3.** That the Election Day polls for said election shall be open from 7:00 a.m. until 7:00 p.m. at the designated polling place and the County Joint Elections Administrator is hereby directed to conduct the election.

**POLLING PLACE:** Eastland County Courthouse

**Section 4.** Early voting by personal appearance for the general election shall commence on April 25, 2022 and continue through May 3, 2022. The Eastland County Courthouse will be open for voting during the early voting period from 8:00 a.m. until 5:00 p.m. Monday thru Friday, except as outlined in Section 5. The place for early voting for such election is hereby designated as follows:

The District Secretary is hereby authorized and directed to provide a copy of this Resolution to the Election Judge as written notice of their appointment as required by Section 32.009 of the Texas Election Code.

**Section 5.** As required under Section 85.005 (d), of the Texas Election Code, early voting by personal appearance at the early voting polling place shall be conducted for at least 12 hours on two weekdays, if the early voting period consists of six or more weekdays; therefore, April 26, 2022 and May 3, 2022 have been designated as the two 12 hours days. The early voting polling place will be open from 7:00 a.m. until 7:00 p.m. on those days.

**Section 6.** The Board of Directors is authorized to sign an Order of Election and the President to sign the Notice of Election prescribed by the State of Texas. The Notice of Election shall be published in accordance with the provisions of the Texas Election Code and the District By-Laws.

**A RESOLUTION OF THE EASTLAND COUNTY WATER SUPPLY DISTRICT, ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 1, 2021 FOR THE PURPOSE OF ELECTING TWO DIRECTORS BY THE QUALIFIED VOTERS OF THE CITY OF RANGER; AUTHORIZING A JOINT ELECTION WITH THE RANGER INDEPENDENT SCHOOL DISTRICT (RISD), AND THE CITY OF RANGER; DESIGNATING THE POLLING PLACES; AND DIRECTING THE NOTIFICATION OF SUCH ELECTION**

**BE IT RESOLVED BY THE EASTLAND COUNTY WATER SUPPLY DISTRICT:**

**Section 1.** That a general election is hereby ordered to be held on the 7th day of May 2022, for the purpose of electing two (2) directors by the qualified voters of the City of Ranger.

**Section 2.** That the Eastland County Water Supply District agrees to hold a joint election with the RISD, and the City of Ranger to be conducted by the Election Clerk.

**Section 3.** That the Election Day polls for said election shall be open from 7:00 a.m. until 7:00 p.m. at the designated polling place and the Election Clerk is hereby directed to conduct the election.




