RESOLUTION 2022-01

A RESOLUTION OF EASTLAND ISD BOARD OF TRUSTEES, EASTLAND, TEXAS, ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 7, 2022, FOR THE PURPOSE OF ELECTING THREE BOARD MEMBERS BY THE QUALIFIED VOTERS OF EASTLAND INDEPENDENT SCHOOL DISTRICT; AUTHORIZING A JOINT ELECTION WITH THE CITY OF EASTLAND, THE EASTLAND MEMORIAL HOSPITAL DISTRICT (EMHD), AND THE EASTLAND COUNTY WATER SUPPLY DISTRICT (ECWSD); DESIGNATING THE POLLING PLACES; AND DIRECTING THE NOTIFICATION OF SUCH ELECTION

BE IT RESOLVED BY THE BOARD OF TRUSTEES OF EASTLAND ISD;

Section 1. That a general election is hereby ordered to be held on the 7th day of May 2022, for the purpose of electing two (3) Board Members by the qualified voters of the Eastland ISD.

Section 2. That Eastland ISD agrees to hold a joint election with the City of Eastland, EMHD, ECWSD.

Section 3. That the Election Day polls for said election shall be open from 7:00 a.m. until 7:00 p.m. at the designated polling place and the County Joint Elections Administrator is hereby directed to conduct the election.

Section 4. Early voting by personal appearance for the general election shall commence on Monday, April 25, 2022 and continue through Tuesday, May 3, 2022. The Eastland County Courthouse will be open for voting during the early voting period from 8:00 a.m. until 5:00 p.m. Monday thru Friday, except as outlined in Section 5. The place for early voting for such election is hereby designated as follows:


The Administrative Secretary is hereby authorized and directed to provide a copy of this Resolution to the Election Judge as written notice of their appointment as required by Section 32.009 of the Texas Election Code.

Section 5. As required under Section 85.005 (d), of the Texas Election Code, early voting by personal appearance at the early voting polling place shall be conducted for at least 12 hours on two weekdays, if the early voting period consists of six or more weekdays; therefore, the first and second Tuesday of the early voting period have been designated as the two 12 hours days. The early voting polling place will be open from 7:00 a.m. until 7:00 p.m. on those days.

Section 6. The Board of Trustees of Eastland ISD is authorized to sign an Order of Election and the Chairman to sign the Notice of Election prescribed by the State of Texas. The Notice of Election shall be published in accordance with the provisions of the Texas Election Code.






