1. Original Eastland County Bail Bond Application
2. Copy of Driver's License, Business License & DBA
3. Company Address and Phone Number on Company Letterhead with copies of Business Cards
4. Criminal History ran through Texas DPS reflecting NO Felonies or Crimes of Moral Turpitude for:
 - a. Owners
 - b. Spouse that has community property or real estate that would be subject to levies
 - c. Company employees
5. Current Certificate of Training for the Texas Bail Bond Course
6. Sufficiency of Sureties Oath
7. Texas Occupation Code 1704 Oath
8. List of Pending Bail Bond Forfeitures or Judgement NISI
9. Certified Financial Statement by a Certified Accountant
10. List of Non-Exempt Real Property and Assets that can be levied against
11. Current Statement from County Appraiser showing Appraised or Market Value and showing Assessed Value of each real parcel used to qualify
12. Proof of Deeds, Titles and Amounts of any Cash or Stock Accounts used as collateral to qualify within 30 days of submission
13. Tax receipts showing ALL TAXES are current from all Taxing Authorities and there is no Tax Liens filed against any property owned from the following:
 - a. Eastland County
 - b. City of Eastland
 - c. Eastland School District
 - d. Any other Taxing Authority where realty is used to qualify
14. Power of Attorney from Spouse to any joint asset used, if Realty, the Power of Attorney must be recorded on the property records of the County wherein the realty lies, if Cash or equivalent accounts, Acknowledgements of the Power of Attorney from each Bank, Credit Union, or Financial Institution.
15. List of ALL Texas or Federal Bail Bonds written and outstanding with the details contained on the suggested forms. If this listing is more than one page, each page must have a subtotal. A total must appear at the end of the report.
16. List of other Counties in which you do business now or intend to do business.

If this is your first time trying to bond with the Eastland County Sheriff's Office (or returning after a lengthy absences), you will be required to submit a Certified Financial Statement every 3 months for the first year. This statement must be by a certified accountant.

It is the Bonding Company's responsibility to fulfill these requirements and to make sure their information is up to date and filed with the Eastland County Sheriff's Office. If your information is missing or out of date, you will be removed from the Bonding List.

If you DO NOT share a good reputation in this County or other Counties in which you have now or previously done business with, you will be removed from the Bonding List.

Rude behavior to Eastland County Sheriff's Office staff or inmates will not be tolerated and will result in removal from the Bonding List.
