




EXHIBIT A

A 0.31 acre tract of land, being all of Lot 5, Block 1, Bennett and Forbess Subdivision to the City of Brownwood, Brown County, Texas, according to the plat or map thereof recorded in Volume 2, Page 17, Plat Records, Brown County, Texas, being that same tract of land described in a deed to Roger Earl Patterson recorded in Volume 1569, Page 447 of the Real Property Records, Brown County, Texas, being more particularly described by metes and bounds as follows:

Beginning at a 1/2" rebar rod (control monument) found in the common line between said Block 1 and 6<sup>th</sup> Street, same being a common corner between said Lot 5 and Lot 6, Block 1, Bennett and Forbess Subdivision, for the South corner of said Patterson tract and the South corner of this described tract;

Thence N 32° 39' 42" W, 72.08 feet along the common line between said Block 1 and 6<sup>th</sup> Street, same being the Southwest line of said Patterson tract, to a 1/2" rebar rod (control monument) found inside a 1" iron pipe for a common corner between said Lot 5 and Lot 4, for the West corner of said Patterson tract and the West corner of this described tract;
