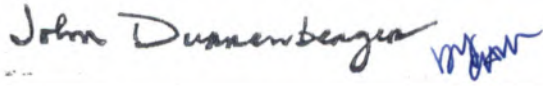
Following each executive session, the Court will reconvene in open session before proceeding to the next executive session.

The Commissioners Court will reconvene in open session for any discussion and possible action regarding matters discussed in executive session.

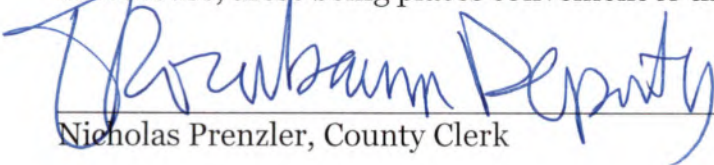

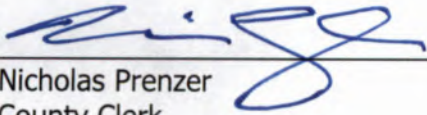

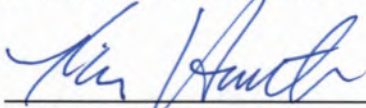
