## What to Bring / YES!

- ◆ Automobile Tires (up to 20" rim size) **NO RIMS**  
Up to 10 tires, over 10 tires \$1.00/tire  
NO Tire Store collected tires; NO 18-Wheel tires
- ◆ Computer Components
- ◆ Used Motor Oil
- ◆ Lead-Acid Batteries
- ◆ Rechargeable Batteries
- ◆ Latex Paint (**IF YOUR PAINT IS NEW AND HAS NEVER BEEN OPENED BRING FOR DISPOSAL**)  
(If Paint has been opened: Please put sand, kitty litter, dog food or something similar into paint and leave lid off to dry. Once dry you can dispose of in trash.)
- ◆ Televisions – **NO** Wooden Consoles

## What **NOT** to Bring / **NO**:

- ◆ **NO INDUSTRIAL OR COMMERCIAL / BUSINESS ITEMS**
- ◆ **NO** Chemicals of **ANY KIND**
- ◆ **NO** Dioxins
- ◆ **NO** Explosives or Ammunition
- ◆ **NO** Medical and Pharmaceutical Items
- ◆ **NO** Compressed Gas Cylinders (aerosols & camp stove propane)
- ◆ **NO** Household products labeled "Caution, Warning or Poison"
- ◆ **NO** Petroleum Based Paints, Stains or Varnishes
- ◆ **NO** Construction / Demolition debris

**Absolutely NO household trash!**

## Limited Bulk Items Accepted:

Couches ◆ Mattresses ◆ Stoves  
Refrigerators ◆ Dishwashers

## Guidelines

- ◆ Bring products in original containers only
- ◆ Do not mix or consolidate products
