Llano County "Local" Historical Medallion Program (LHMP)

Recommendation: The establishment of a Llano County "Local" Historical Medallion Program.

- The LCHC shall establish and recommend the rules and criteria for "Local" Historical Medallions for Llano County historic structures, events and or persons which do not meet criteria for the THC Texas Historic Marker Program.

Purpose: The Llano County "Local" Historical Medallion Program (LHMP) is to:

1. Recognize, promote and preserve the history of Llano County.
2. Many Llano County historic structures, events or people that do not meet the criteria for the THC Marker Program deserve "local" Historical recognition.
3. The LHMP includes Historical recognition of culture, structures, genealogy, historical treasures and archival information (data and photographic).

Criteria: To qualify for a "Local" Historical Medallion:

1. Building(s) must be at least 50 years old and have significance in the history of Llano County.
2. Historical: associated with a specific time in county's history or association with a person connected with significant history within the county.
 - Architectural-unique to a certain period of time within Llano County's history
 - Social-A way of life specific to Llano County and its history.
3. Event:
 - Must be at least 30 years previous to application.
 - Newsworthy and thus has support documentation easily found.
 - Significant impact on the county.
4. Person:
 - Person to be recognized must have been deceased for 10+ years.
 - Contributed to Llano's history in a significant manner (noteworthy thus documentation found in newspaper, etc.)

Process: Application for a "Local" Historical Medallion:

- Complete and submit application to Llano County Historical Commission.
- Provide a historical narrative supporting the nominated structure, event or person, not to exceed 5 pages (double spaced, typewritten including reference notes, bibliography).
- Submit this narrative and include any documentation and photographs of proposed marker structure, event, person.
- Other documentation as needed.

Approval: Application for a "Local" Historical Medallion:

- If approved, the LCHC shall present the approved application to the Llano County Commissioner Court for approval or disapproval.
- If approved and the medallion would be located within the jurisdiction of an incorporated City, the LCHC shall present the approved application to the City Council of said City for approval or disapproval.
- If approved the applicant shall be notified by the LCHC.
 1. The applicant shall submit payment for the cost and installation of medallion.
 2. The LCHC shall provide and/or order said Historical Medallion.

Disapproval: Application for a "Local Historical Medallion:

- If said application is disapproved the LCHC shall inform the applicant in writing clearly stating the reason/reasons for disapproval.
