## COMMISSIONER'S COURT

### Regular Meeting


Throckmorton County Commissioners' Court met in Regular Session on Monday the 10th day of August, 2020, at 9:00 A.M., at 105 North Minter, Throckmorton, Texas, with the following members present:

Present: Trey Carrington, County Judge, Casey Wells, Commissioner Pct#1, Kasey Hibbitts, Commissioner Pct#2, Lance Sullivan, Commissioner Pct#3, Klay Mitchell, Commissioner Pct#4, Dianna Moore, County Clerk, Brenda Rankin, County Treasurer, Bobby Thompson, Kirby Gober, Jay Cantrell, Rob Neely, Trent McKnight, and Doc Wigington.

1. Trey Carrington called meeting to order at 9:03 A.M. and welcomed guest.
2. Dianna Moore read minutes from the previous meeting. Klay Mitchell made the motion with Casey Wells seconding to approve the minutes. Motion carried 5-0.
3. Kirby Gober reported to the Court that the Hospital Board approved bills at the last meeting in the amount of \$217,302.51. An X-Ray machine was purchased for \$66,250.00, a keyless entry to the doors was installed for the employees to use a card to enter, which was \$20,000.00, and in the process of recoating the roof, which is all being paid out of the Care Account. Lance Sullivan made the motion with Kasey Hibbitts seconding to approve and pay the bills. Motion carried 5-0.
4. Citizen's Hearing was held. Trent McKnight addressed the court as a follow up from the King Creek 1 project and would like to express that he still would like for the court to vote against the windmills. He also expressed how he would like to preserve the Swenson Ranch history and would like to contribute \$2,000,000.00 to the county and assist the county in long term projects. He would also like to help with building a new fire hall. He has contacted an architect and would like to collaborate with the school. The exhibit that is attached is a firehall that resembles the Courthouse and he would like to combine it with the Mechanics program with the school. Trent stated that he would like to work with the court and asked again for them to vote no against the windfarms. Trey Carrington asked Trent how could we make that decision when Ross McKnight is for the windfarms? Trent stated that him and his mother are against them and that he feels like he is on the opposite end and wants to do projects that will benefit the community and not just for his family.
5. No action on line item #5.
6. Entered into closed session under Article 551.071 at 9:25 am.
7. Exit closed session at 9:59 am. No action taken.

8. Budget Workshop was held.
9. Elected Officials Report: Doc Wigington reported that he received dates from TDCJ on when inmates can be transported. The first week in September, one inmate will be transported and the third week of September, the other three inmates will be transported. Females will be transported to Gatesville and Liberty County. The state has ordered that no trials will be held until after January. We have one inmate in Stephens County with Covid, two more have been tested, and two inmates have bonded out. We have eight in jail and have hearings on Motion to Revoke set. Had 15 indictments from Grand Jury and most were dope related. Need to purchase two more vest and would like to purchase spike sticks. He also reported that Byron Gray has started the academy through distance learning and will graduate at Thanksgiving. He will have to spend one month at College Station and will need to take one of the vehicles there for two weeks.
10. Brenda Rankin presented the court with the county bills. Kasey Hibbitts made the motion with Lance Sullivan seconding to approve and pay the bills. Motion carried 5-0.
11. Casey Wells made the motion and seconded by Klay Mitchell to adjourn at 10:41 am. Motion carried 5-0.

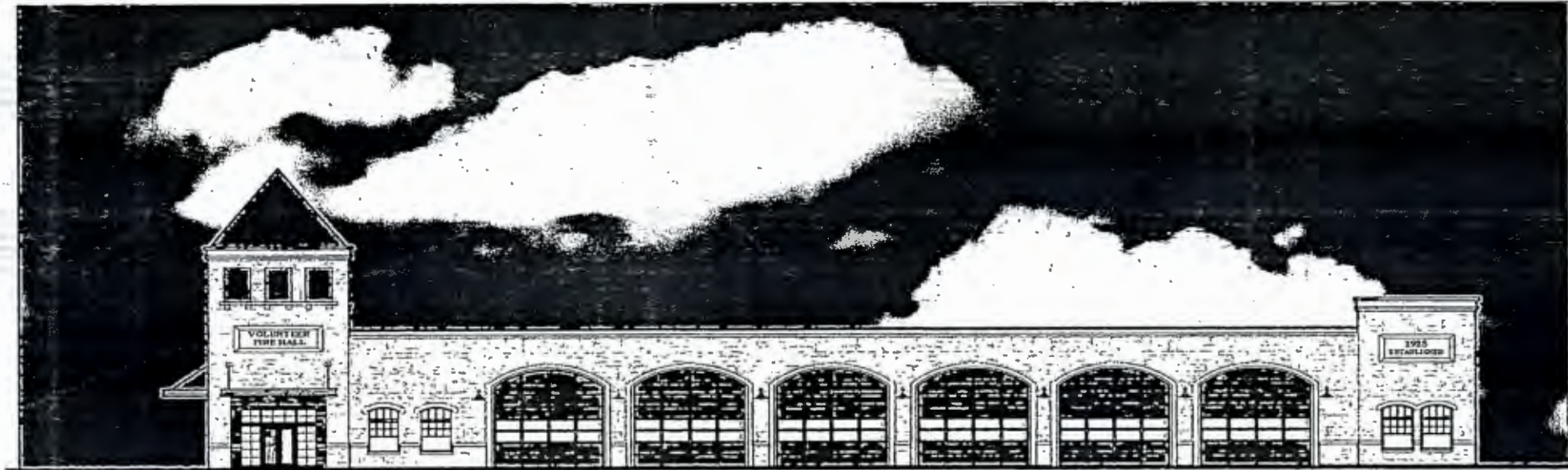
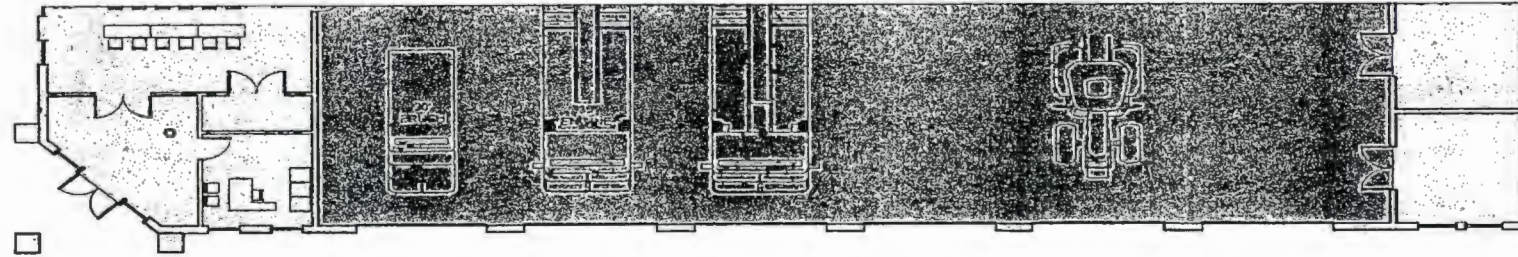
