Regular Meeting

Throckmorton County Commissioners' Court met in Regular Session on Monday the 8th day of December 2025 at 9:00 a.m., at 105 North Minter, Throckmorton, Texas, with the following members present:

Others present: Michelle Clark, Glen Whitfield, Bobby Thompson, Brad Bellah, Alan Stephens, Jack Fauntleroy, and Bryan Key.

1. Caleb Hodges called the meeting to order at 9:00 am and welcomed all guest. Commissioner Wells was absent.
2. Minutes from the previous meeting were reviewed. Kasey Hibbitts made the motion with Klay Mitchell seconding to approve the minutes. Motion carried 4-0.
3. Bryan Key presented the Hospital report and bills to the court. Bryan stated the board approved the bills in the amount of \$270,194.43. This amount includes the repair on the AC on the ambulance. Budget for 2026 was approved and had to pay the cost on website per government guidelines. Bryan also requested to get the remaining \$200,000.00 county subsidy for 2025. Klay Mitchell made the motion with Greg Brockman seconding to approve the report and pay the bills. Motion carried 4-0.

Klay Mitchell made the motion with Kasey Hibbitts seconding to disburse charitable contributions from the Windfarm as follows: Elbert Cemetery \$5500.00, Woodson Community Center \$6000.00, Salt and Light \$3000.00, Chamber of Commerce \$5500.00, and Senior Citizen's Building \$5000.00. Motion carried 4-0.
7. Caleb Hodges made the motion with Klay Mitchell seconding to sign the Joint Resolution for a Joint Primary Election. Resolution is attached. Motion carried 4-0.
8. Elected Officials Report: Klay Mitchell discussed tables for the show barn and that he found some in Wichita Falls. Michelle Clark stated that she will not be here the week of the 20<sup>th</sup> and that everything will be ready, and Hayley will be taking care of it all.
9. Michelle Clark presented the bills to the court. Kasey Hibbitts made the motion with Klay Mitchell seconding to pay the bills. Motion carried 4-0.

11. Greg Brockman made the motion and seconded by Kasey Hibbitts to adjourn at 9:53 a.m. Motion carried 4-0.
