

The Commissioners' Court of Throckmorton County, Texas, meeting in regular session on the 25th day of October, 2021, considered the following resolution:

BE IT ORDERED BY THE COMMISSIONERS' COURT OF THROCKMORTON COUNTY, TEXAS AS FOLLOWS

Motion by Commissioner RH4 KlayMitchell seconded by Judge Trey Caeeing for, that the following action be taken by the court:

- 1. THAT the County hereby designates the property located in Throckmorton County, having the boundary description in Exhibit A and shown on the map in Exhibit B, both attached to this **Order**, as a Reinvestment Zone under the Throckmorton County Guidelines and Criteria for Granting Tax Abatements, having determined that the designation will contribute to the retention or expansion of primary employment and will attract major investment in the zone that will benefit the zone and will contribute to the reconomic development of the County, and
- 2. THAT the County hereby certifies as correct and accurate the description and boundaries depicted on the attached Exhibits A and B; and
- 3. THAT the County hereby declares itself eligible for property tax abatement all eligible property for commercial-industrial development, now or thereafter located in that Reinvestment Zone as authorized by the Throckmorton County Guidelines and Criteria for Granting Tax Abatements in Reinvestment Zones and Chapter 312 of the Texas Tax Code.
- 4. THAT the zone shall be called the "Throckmorton County Reinvestment Zone 2021-1."



## Map of Reinvestment Zone


