



1. Caleb Hodges called meeting to order at 9:00 A.M. and welcomed guest.
2. Minutes from the previous meeting were reviewed. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve the minutes. Motion carried 5-0.
3. No action
4. Citizen's Comments: No comments.
5. Klay Mitchell made the motion with Kasey Hibbitts seconding to replace the Air Conditioner Condenser in the courtroom. Motion carried 5-0.
6. Kasey Hibbitts made the motion with Casey Wells seconding to fund the 20% of fire truck after the grant for the Throckmorton Volunteer Fire Department for a brush truck. Motion carried 4-0 with Klay Mitchell abstaining.
7. Caleb Hodges made the motion with Greg Brockman seconding to reappoint Casey Wells to the Throckmorton County Appraisal District Board of Directors. Motion carried 4-0 with Casey Wells abstaining.
8. Caleb Hodges made the motion with Kasey Hibbitts seconding to offer County employees the ability to participate in any aspect of ID Shield and will be a payroll deductible. Motion carried 5-0.
9. Klay Mitchell made the motion with Kasey Hibbitts seconding to approve the Throckmorton County Budget for 2026. Motion carried 5-0.
10. Klay Mitchell made the motion with Greg Brockman seconding to set the final Tax Rate for 2025 at .999100. Motion carried 5-0.
11. Elected Officials Report: Caleb Hodges reported that the old nursing home lot has been mowed. Caleb also stated that the Cyber Security Compliance for employees is coming up soon to be completed. Caleb received a letter from the city that they will be withdrawing the pay for the 2nd deputy. The county will keep the 2nd deputy and will use the SB22 funds. The Senior Citizens have a piano that is not any good and has asked for help removing it.
12. Michelle Clark presented the bills to the court. Caleb Hodges made the motion with Kasey Hibbitts seconding to pay the bills and to approve the expenses to be paid for Dianna Moore's conference in October. Motion carried 5-0.
