Klay Mitchell, Commissioner Pct. 4




Others present: Michelle Clark, Glen Whitfield, Bobby Thompson, Bryan Key, and Kirby Gober

1. Caleb Hodges called meeting to order at 9:00 A.M. and welcomed guest.
2. Minutes from the previous meeting were reviewed. Kasey Hibbitts made the motion with Casey Wells seconding to approve the minutes. Motion carried 5-0.
3. Kirby Gober presented the Hospital bills and report. Mr. Gober stated that the board approved the bills in the amount of \$336,036.86 and stated it was a routine month. He stated that \$48,500.00 was a IGT payment, but will get that back plus some in about a month. The budget was presented at the board meeting. Caleb Hodges made the motion with Klay Mitchell seconding to approve the report and pay the bills. Motion carried 5-0.
4. Citizen's Comments: no comments were made.

8. The bills were reviewed, Kasey Hibbitts made the motion with Klay Mitchell seconding to approve and pay the bills. Motion carried 5-0.
