

All that certain lot, tract, or parcel of land, being 0.430 acre situated in the Roy Alford Survey, Abstract No. 12, in Hubbard, Hill County, Texas, and being the same tract conveyed in deed from Evelyn McAdams to Tony B. York and wife, Mariana York; dated September 12, 1967, and recorded in Volume 480 Page 402, in the Official Public Records of Hill County, Texas. Said 0.430 acre is more fully described as follows;

Beginning at a 1/4" rod found for the north corner of this tract and in the east corner of the Randy Milne tract, and in the southwest line of North Magnolia Street, a/k/a State Highway 171, Volume 287 Page 563;

Thence south 30 degrees 00 minutes 00 seconds east along the northeast line of this tract and the southwest line of North Magnolia Street, a distance of 125.00 feet to a 1/4" rod set of the east corner of this tract and the north corner of the Patricia Phillips tract;

Thence south 60 degrees 00 minutes 00 seconds west along the southeast line of this tract and the northwest line of the Phillips tract, a distance of 150.00 feet to a point in concrete for the south corner of this tract, and in the west corner of the Phillips tract, and a 2" iron fence corner post brs. south 30 degrees 00 minutes 00 seconds east a distance of 0.30 feet;

Thence north 30 degrees 00 minutes 00 seconds west generally along a fence and along the southwest line of this tract, a distance of 125.00 feet to a 1/4" rod set for the west corner of this tract and in the south corner of the Milne tract;

Thence north 60 degrees 00 minutes 00 seconds east along the northwest line of this tract and the southeast line of the Milne tract, a distance of 150.00 feet to the place of beginning and containing 0.430 acre of land.
