#### **Position Summary**

The purpose of this position is to provide security for the occupants and public visitors of the Karnes County Courthouse and other county facilities. This is accomplished by patrolling the Courthouse, other County facilities as well as the exterior grounds; visually screening each person as they enter the buildings.

#### Working Conditions

This position works in the Courthouse, other County facilities and outdoors. Exposure to environmental conditions is moderate; exposure to health and safety conditions is low. Protective equipment required includes firearms, taser, and body armor. Standing, reaching, handling, vision, balancing and hearing are constantly required. Fine dexterity, walking, pushing, pulling, foot controls, twisting and talking are frequently required. Occasionally, lifting and sitting are required.

### **ESSENTIAL FUNCTIONS**

#### Job Function

- Screens persons and property at all points of courthouse entry; monitors people entering the courthouse along with the possessions of those entering the courthouse; involves visual inspection, engages courthouse customers in conversation (providing additional level of contraband detection); provides directions to officers; directs people to building exit.
- Conducts periodic foot patrol of all the courthouse, parking lot, and other County facilities.
- Performs opening and closing procedures of the courthouse by physically walking all levels of the courthouse conducting a visual inspection; reports any maintenance issues discovered.
- Maintains equipment by ensuring it is used properly and calibrated throughout the workday.
- Generates reports, records and logs related to courthouse and other County facilities activity.
- Assists Bailiffs as needed; provides security or assistance in detaining, restraining or arresting individuals.
- Escorts customers from a County facility to the parking lot as needed.
- Provides security at the commissioner's court and other meetings, as needed.
- Perform all and any other related duties as assigned.
