13. RECEIVE REPORTS FROM DEPARTMENT HEADS.



14. PAY CLAIMS AND LINE-ITEM ADJUSTMENTS AS REQUESTED.


Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to pay claims 83-188. The motion carried.

15. ADJOURN.


Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to adjourn. The motion carried.






