5. CONSIDER APPROVAL OF AN AGREEMENT WITH ROBERTS & MCGEE TO CONDUCT THE ANNUAL AUDIT OF NOLAN COUNTY FINANCES.

Motion was made by Commissioner Willman, seconded by Commissioner White to approve the agreement with Roberts & McGee. Vote was taken and members of the court unanimously voted yes. Motion carried.

8. CONSIDER APPROVAL OF THE PURCHASE OF OFFICE SUPPLIES.

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to approve the purchases. Vote was taken and members of the court unanimously voted yes. Motion carried.

9. CONSIDER APPROVAL TO APPOINT DR. JENNIFER LIEDTKE AS THE HEALTH AUTHORITY FOR NOLAN COUNTY.

Motion was made by Commissioner White, seconded by Commissioner Willman to approve the appointment of Dr. Liedtke as the Health Authority for Nolan County. Vote was taken and members of the court unanimously voted yes. Motion carried.

10. CONSIDER APPROVAL OF A SECOND CONTRACT RENEWAL OF THE STATEWIDE AUTOMATED VICTIM NOTIFICATION SERVICE (SAVNS).

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to approve the SAVNS contract renewal. Vote was taken and members of the court unanimously voted yes. Motion carried.

11. RECEIVE AND CONSIDER APPROVAL OF THE ANNUAL REPORT OF DESKTOP AUDITS FROM NOLAN COUNTY AUDITOR.

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to approve the annual desktop audits. Vote was taken and members of the court unanimously voted yes. Motion carried.

12. CONSIDER APPROVAL OF A RESOLUTION AUTHORIZING A COUNTY GRANT PROGRAM YEAR 2022 FOR THE CITY OF SWEETWATER SENIOR NUTRITIONAL ACTIVITIES PROGRAM (SNAP).

Motion was made by Commissioner Ortega, seconded by Commissioner White to approve the resolution. Vote was taken and members of the court unanimously voted yes. Motion carried.

13. RECEIVE REPORTS FROM DEPARTMENT HEADS.



15. ADJOURN.
