

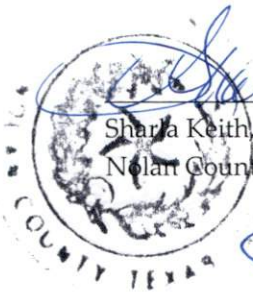
2. CONSIDER APPROVAL OF NOLAN COUNTY CONSTABLE CIVIL FEES.
