**3. APPROVE MINUTES OF THE MARCH 22<sup>nd</sup>, 2021 MEETING.**

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to approve the minutes as presented from the March 22<sup>nd</sup>, 2021 meeting. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**4. CONSIDER APPROVAL OF A PROCLAMATION NAMING APRIL CHILD ABUSE AWARENESS MONTH.**

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to approve the Proclamation naming April as Child Abuse Awareness Month. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**5. CONSIDER APPROVAL OF A PROCLAMATION NAMING APRIL NATIONAL 911 EDUCATION MONTH.**

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to approve the Proclamation naming April as National 911 Education Month. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**6. CONSIDER APPROVAL OF A PROCLAMATION NAMING APRIL 25 – MAY 2, 2021 SOIL & WATER STEWARDSHIP WEEK.**

Motion was made by Commissioner Willman, seconded by Commissioner White to approve the Proclamation naming April 25 - May2, 2021 Soil & Water Stewardship Week. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**7. CONSIDER APPROVAL TO PURCHASE 2 HARD DRIVES AND CLOUD DATA RETENTION FROM YOURWAY.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve the purchase of 2 Hard Drives and Infinite Cloud Data Retention from Yourway Computer Tech Team. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**8. CONSIDER APPROVAL OF A NOLAN COUNTY ROAD CROSSING AGREEMENT FOR NOLAN COUNTY ROAD 130.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner Willman to approve the Road Crossing Agreement for CR 130, with Blair Water Supply Corporation, installing a new water meter for Lone Star NGL Pipeline. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**9. CONSIDER APPROVAL OF A RESOLUTION TO OPPOSE HOUSING TAX CREDITS WITH THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner White to approve a Resolution in Opposition to Housing Tax Credits with the Texas Department of Housing and Community Affairs. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**10. CONSIDER APPROVAL OF A NEW NETWORK ATTACHED STORAGE DEVICE (NAS) FOR THE NOLAN COUNTY SHERIFF'S OFFICE.**

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to approve a new (NAS) for the Nolan County Sheriff's Office. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**11. CONSIDER APPROVAL TO PURCHASE PRO-VISION HD BODY CAMERAS AND ACCESSORIES.**

Motion was made by Commissioner Ortega, seconded by Commissioner Willman to approve the purchase of Pro-Vision HD Body Cameras and Accessories using funds from the anonymous donor gift. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**12. RECEIVE REPORTS FROM DEPARTMENT HEADS.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to receive reports from the Texas Wildlife Services Program, the Texas Agricultural Extension Service travel substantiation and accountability, the Nolan County Coliseum Board, Inc., the Nolan County Clerk, the Nolan County Treasurer Financial Report and the Nolan County Auditor Financial Report Fund Balance. Vote was taken and the members of the Court unanimously voted yes. Motion carried.

**13. PAY CLAIMS AND LINE-ITEM ADJUSTMENTS AS REQUESTED.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to pay claims 1-128, and line item adjustments. Vote was taken and the members of the Court unanimously voted yes. Motion carried.






