**3. APPROVE MINUTES OF THE APRIL 12<sup>th</sup>, 2021 MEETING.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to approve the minutes as presented from the April 12<sup>th</sup>, 2021 meeting. Vote was taken and members of the Court unanimously voted yes. Motion carried.

**4. CONSIDER APPROVAL TO REINSTATE THE BURN BAN.**

**5. CONSIDER APPROVAL TO PURCHASE A SUPERIOR BROOM FOR ALL NOLAN COUNTY PRECINCTS.**

**8. RECEIVE REPORTS FROM DEPARTMENT HEADS.**


