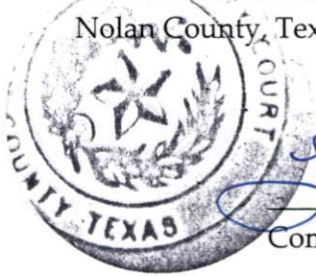
2. ADJOURNED






