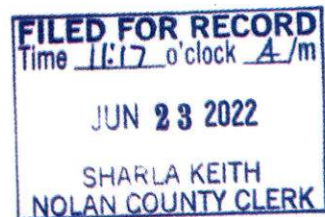
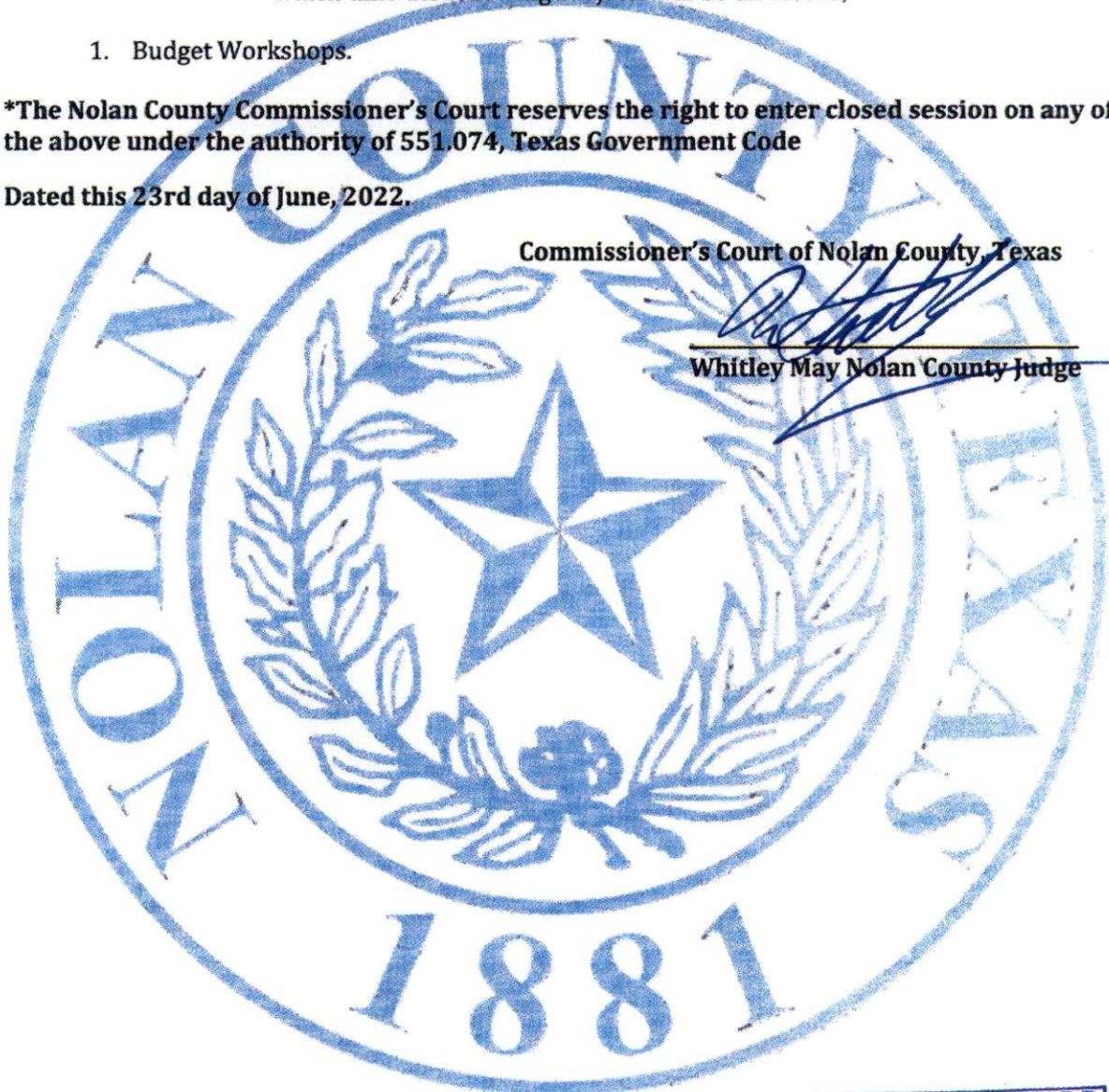

## 2. ADJOURNED

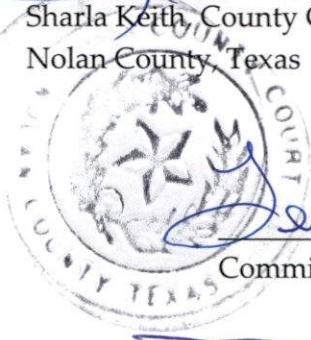
Motion was made by Commissioner White, seconded by Commissioner Willman to adjourn. Vote was taken and the members of the Court unanimously voted yes. Motion carried.




