


**NOTICE OF MEETING OF

**1. PLEDGE ALLEGIANCE TO THE UNITED STATES FLAG**

**2. PLEDGE ALLEGIANCE TO THE TEXAS FLAG**

**3. APPROVE MINUTES OF THE SEPTEMBER 26<sup>TH</sup> and 30<sup>TH</sup>, 2022 MEETINGS.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve the minutes as presented from the September 26<sup>th</sup> and 30<sup>th</sup>, 2022. Vote was taken and members of the court unanimously voted yes. Motion carried.

**4. CONSIDER APPROVAL TO REMOVE/REINSTATE THE NOLAN COUNTY BURN BAN.**

Motion was made by Commissioner White, seconded by Commissioner Ortega for the Nolan County Burn Ban to remain off. Vote was taken and members of the court unanimously voted yes. Motion carried.

**5. OPEN AND RECEIVE BIDS FOR A WATER TRUCK FOR THE NOLAN COUNTY COLISEUM.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner Ortega to receive the bid from United Rentals for a water truck. Vote was taken and members of the court unanimously voted yes. Motion carried.

**6. AWARD BID FOR WATER TRUCK.**

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to award the bid from United Rentals for a water truck for the Nolan County Coliseum. Vote was taken and members of the court unanimously voted yes. Motion carried.

**7. CONSIDER APPROVAL FOR THE NOLAN COUNTY COLISEUM TO PURCHASE TABLES AND CHAIRS WITH REIMBURSEMENT FROM THE CHAMBER OF COMMERCE FOR HALF OF THE PURCHASE PRICE.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner White to approve the purchase of tables and chairs for the Nolan County Coliseum, splitting the cost between the Coliseum and Chamber of Commerce. Vote was taken and members of the court unanimously voted yes. Motion carried.

**8. CONSIDER APPROVAL OF A RESOLUTION AUTHORIZING COUNTY GRANT PROGRAM YEAR 2023 FOR SENIOR NUTRITIONAL ACTIVITIES PROGRAM (SNAP).**

Motion was made by Commissioner Willman, seconded by Commissioner Ortega to approve a Resolution authorizing the County Grant Program Year 2023 for SNAP. Vote was taken and members of the court unanimously voted yes. Motion carried.

**9. CONSIDER APPROVAL OF A RESOLUTION FOR THE INDIGENT DEFENSE GRANT PROGRAM.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to approve a Resolution for the Indigent Defense Grant Program. Vote was taken and members of the court unanimously voted yes. Motion carried.

**10. CONSIDER APPROVAL OF REQUESTED AUDIT OF FORFEITURE FUNDS FOR THE 32<sup>ND</sup> JUDICIAL DISTRICT ATTORNEY'S OFFICE ACCORDING TO ARTICLE 59.06.**

Motion was made by Commissioner White, seconded by Commissioner Ortega to approve the requested audit of forfeiture funds for the 32<sup>nd</sup> Judicial District Attorney's Office. Vote was taken and members of the court unanimously voted yes. Motion carried.

**11. CONSIDER APPROVAL TO PURCHASE A BACKHOE THROUGH SOURCEWELL OR BUY BOARD.**

Motion was made by Commissioner Mahaffey, seconded by Commissioner White to approve purchasing a backhoe for \$137,000 through Sourcewell or Buy Board. Vote was taken and members of the court unanimously voted yes. Motion carried.

**12. CONSIDER APPROVAL OF A CONTRACT FOR PEST CONTROL/LAWN CARE AT THE NOLAN COUNTY JAIL.**

Motion was made by Commissioner White, seconded by Commissioner Mahaffey to approve a contract with Nemir Pest Control for the Nolan County Jail. Vote was taken and members of the court unanimously voted yes. Motion carried.

**13. RECEIVE REPORTS FROM DEPARTMENT HEADS.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to receive reports from the Nolan County Tax Office, the Texas Wildlife Services Program, the Nolan County Clerk, the Sweetwater Nolan County Welfare Association, the County Treasurer Financial Report and Minutes, and the County Auditor Financial Report Fund Balance. Vote was taken and members of the court unanimously voted yes. Motion carried.

**14. PAY CLAIMS AND LINE-ITEM ADJUSTMENTS AS REQUESTED BY THE COUNTY AUDITOR.**

Motion was made by Commissioner Willman, seconded by Commissioner Mahaffey to pay claims 1-94 and line-item adjustments. Vote was taken and members of the court unanimously voted yes. Motion carried.

**15. ADJOURN.**




