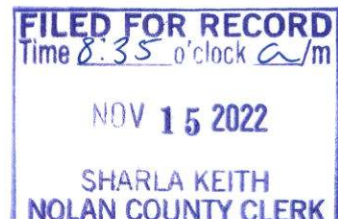
1. **Go out for bids for an HVAC System for the Nolan County Coliseum.**


**3. CANVASS VOTES.**


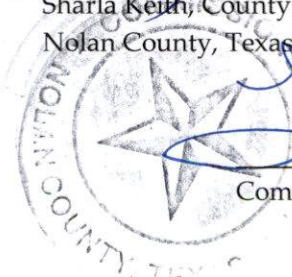
**4. ADJOURN.**


