
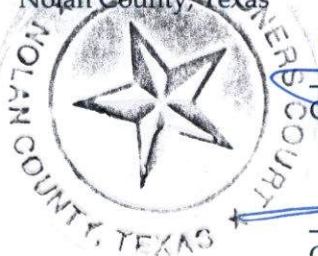



13. ADJOURN.
