**7. Pay claims and line-item adjustments as requested by the County Auditor.**

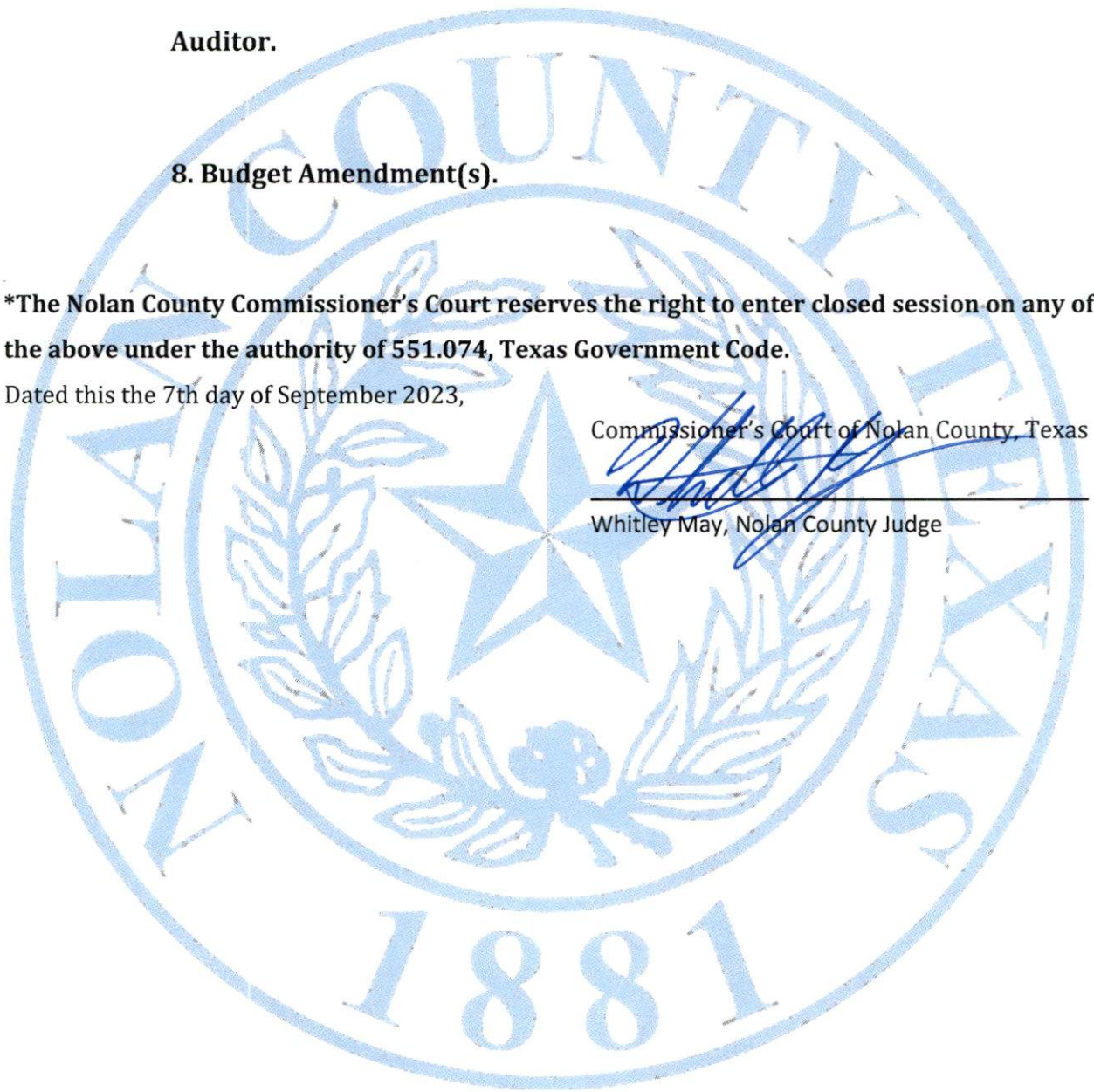


**9. ADJOURN.**




