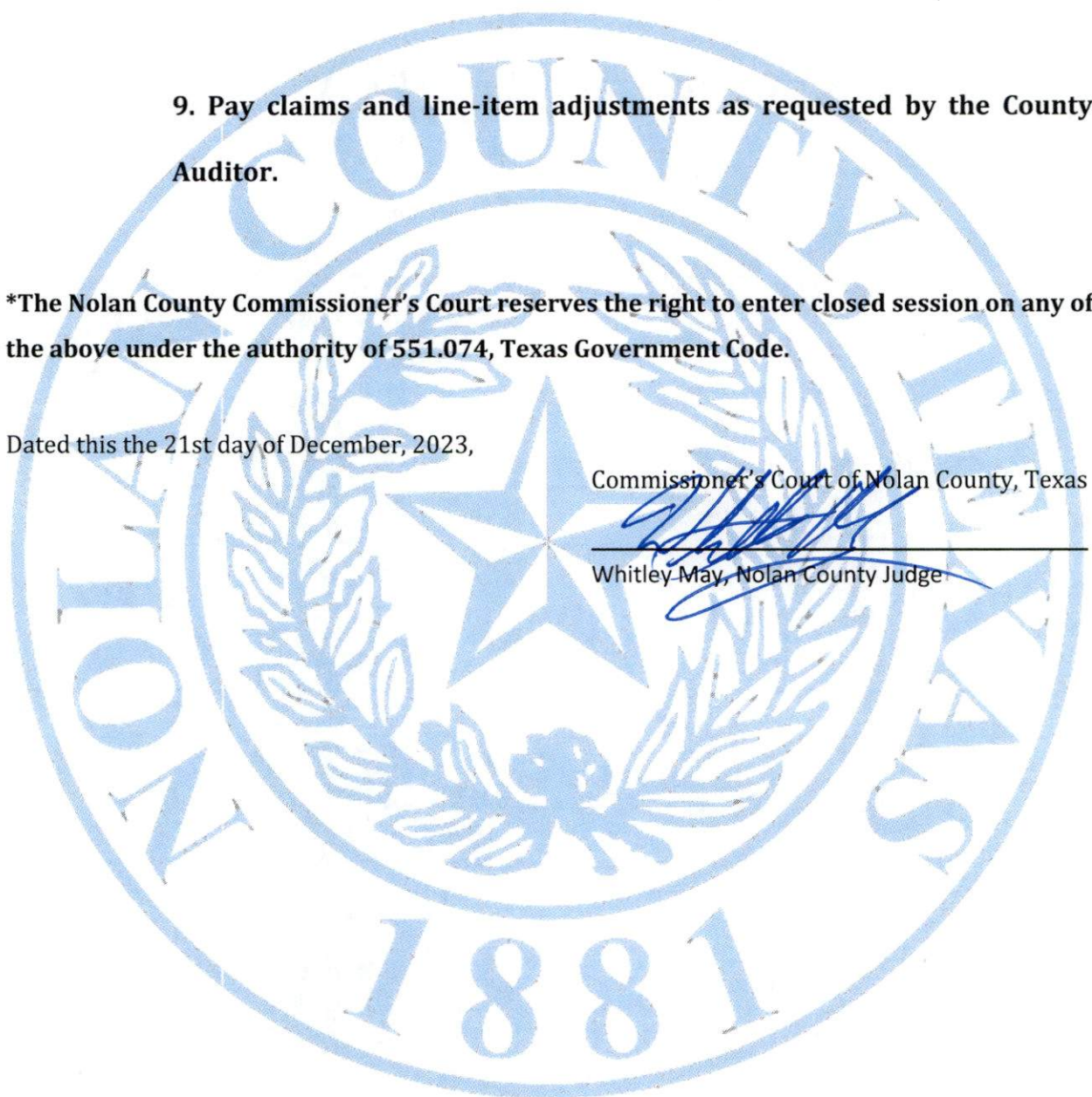

**10. ADJOURN.**

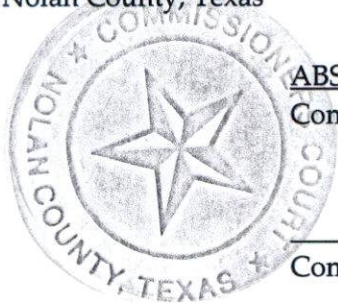




