
**2. AWARD BIDS FOR BOILER/HOT WATER SYSTEM FOR THE JAIL.**

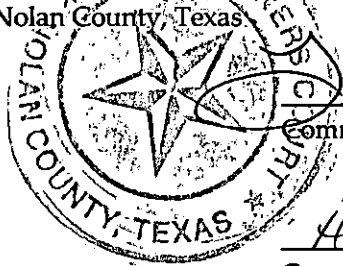
**3. ADJOURN.**
