Field notes of a 10.97 acre tract of land, more or less, being comprised of a called 6.7 acre tract (Less 1.33 Ac.) (Tract 1) and a called 5.4 acre tract (Tract 2) conveyed from Beverly Jean Overstreet to 16767 SH80, LLC, by Deed recorded in Volume 1110, Page 711 of the Official Public Records of Karnes County, Texas;

Said 10.97 acre tract, which is comprised of a portion of the John F. Miller Survey, Abstract 192, is situated in Karnes County, approximately 2.5 miles south of the town of Gillett and is described by metes and bounds as follows:

BEGINNING at a 5/8" iron rod (with cap stamped "RPLS 6198") found at the northeast corner of said called 5.4 acre tract and the intersection of the southern right-of-way line of County Road 292 with the western right-of-way line of State Highway 80, for the northeast corner of this tract;

THENCE S 10° 44' 39" W along the east line of this tract, the east line of said called 5.4 acre tract and the western right-of-way line of said State Highway 80, at 550.87 ft. pass a 5/8" iron rod (with cap stamped "RPLS 6198") found at the southeast corner of said called 5.4 acre tract and the northeast corner of said called 6.7 acre tract, continuing along the east line of said called 6.7 acre tract, in all a distance of 1575.99 ft. to a 1/2" iron rod found at a fence corner post at the northeast corner of a called 1.33 acre tract conveyed to Mary L. & Calvin E. Daugherty by Deed recorded in Volume 555, Page 241 of said Official Public Records, for the southeast corner of this tract;

THENCE N 75° 47' 34" W generally with a fence along the south line of this tract, the north line of said called 1.33 acre tract and crossing said called 6.7 acre tract, a distance of 167.06 ft. to a 5/8" iron rod found near a fence corner post in the west line of said called 6.7 acre tract and at the northwest corner of said called 1.33 acre tract, for the southwest corner of this tract, same being also a point in the east line of a called 52.5 acre tract conveyed to Jerry Clemens by Deed recorded in Volume 148, Page 32 of the Deed Records of Karnes County, Texas;

THENCE N 00° 15' 56" W generally with a fence along the west line of this tract, the west line of said called 6.7 acre tract and the east line of said called 52.5 acre tract, at 972.33 ft. pass a 5/8" iron rod (with cap stamped "RPLS 6198") found at the northwest corner of said called 6.7 acre tract and the southwest corner of said called 5.4 acre tract, continuing along the west line of said called 5.4 acre tract, in all a distance of 1497.50 ft. to a 10" treated fence corner post in the southern right-of-way line of said County Road 292, at the northwest corner of said called 5.4 acre tract and the northeast corner of said called 52.5 acre tract, for the northwest corner of this tract;

THENCE N 88° 46' 39" E with a fence along the north line of this tract, the north line of said called 5.4 acre tract and the southern right-of-way line of said County Road 292, a distance of 462.80 ft. to the POINT OF BEGINNING, containing 10.97 acres, more or less.
