AMENDMENT TO RESOLUTION

ORDER OF ELECTION FOR A BORGER INDEPENDENT SCHOOL DISTRICT
VOTER-APPROVAL TAX RATE ELECTION (VATRE) ON NOVEMBER 4, 2025

THE STATE OF TEXAS

WHEREAS, on August 14, 2025, the Board of Trustees of Borger Independent School District (the "District") duly adopted a Resolution and Order of Election for a Voter-Approval Tax Rate Election (the "Order") to be held on November 4, 2025; and

WHEREAS, Section 10 of the Order authorized Daniel Fuller, the Superintendent of the Borger Independent School District, acting as the Secretary's agent, to take all reasonable and necessary actions to ensure that the Election is fairly held and the returns properly received, counted, and tabulated, and to make such modifications to the Order as may be required by state or federal law, to correct technical matters, or otherwise to carry out the intent of the Board of Trustees, and all such actions are expressly ratified and confirmed; and

WHEREAS, Borger ISD has been notified of a change in polling place for precincts 31 and 41 by the Hutchinson County Elections Administrator;

NOW, THEREFORE, THE SUPERINTENDENT, ACTING AS SECRETARY'S AGENT PURSUANT TO THE AUTHORITY GRANTED IN THE ORDER, THAT THE ORDER IS AMENDED AS FOLLOWS:

Amendments to the Order and its exhibits are indicated by underlining hereinafter. Any sections of the original Order that are not expressly identified in this document remain in full force and effect. These amendments are made to replace polling places during the conduct of the Election by the authority of the Superintendent as the Board's designated agent.

The polling places for Election Day shall be open November 4, 2025, from 7:00 A.M. 7:00 P.M and are located as follows:


